Minutes of the 4th (Fourth) Alumni Meet (General Body Meeting) of the Utkal Statistics Alumni Association (USAA) held on 28.01.2018 (Sunday).

The 4th (Fourth) Alumni Meet of the Utkal Statistics Alumni Association (USSA) was held under the Chairmanship of Dr Jitendriya Sarangi, President of the Association, in the PG Council Conference Hall, Utkal University, Vani Vihar, Bhubaneswar on 28.01.2018 (Sunday). Registration of participants started sharp at 09:30 am and each participant was given a set of reference materials i.e. (i) the programme for the day, (ii) a copy of the Annual Report of USAA for the year 2016-17, and (iii) a copy of the Souvenir "ଉଷା – 2018" the second issue in its series.

The Alumni meet was organised in 3 (three) sessions i.e. (i) Inaugural Session, (ii) Interactive Session, and the (iii) Entertainment Session with a Lunch Break in the middle.

I. INAUGURAL SESSION: (10:00 am to 11:30 am)

Sri Dhirendra Kumar Patnaik, IAS, Director (Higher Education) was invited as Chief Guest of the day. Dr Soumendra Mohan Patnaik Vice-Chancellor, Utkal University and Dr Brahmananda Satapathy, Chairman PG Council, Utkal University were invited as Guests of Honour to this occasion.

At the outset, the Utkal University Theme Song was played in a pin drop silence atmosphere.

Sri Rabindra Kumar Mohanty, Vice-President, USAA, gave an overwhelming warm welcome address on the occasion. He extended his hearty welcome to Dr Jitendriya Sarangi, Hon'ble President USAA, Sri Dhirendra Kumar Patnaik, IAS, Hon'ble DPI (H E, Odisha), Dr Soumendra Mohan Patnaik, Hon'ble Vice-Chancellor, Utkal University, Dr Brahmananda Satapathy, Hon'ble Chairman PG Council, Utkal University as well as all the Alumni Members present on the occasion.

After the welcome address, an Opening Chorus Song with instruments, "Bande Hain hum Uske" was staged by students of the PG Department of Statistics, Sri Kamalakants Sahoo 6th yr, Ms Prajna Prasamita Mohanty 6th yr, Ms Deeptimayee Panda 6th yr, Ms Sangita Barik 6th yr, Sri Bikash Kanday 5th yr, Sri Satayu Santiduta Panda 5th yr, Ms Padmabati Samantaray 6th yr and Ms Shubhasmita Das 5th yr.

- (i) For kind information of esteemed guests and the Alumni Members, the President, USAA gave a brief account of the initiatives taken and the progress made during the last year by the Alumni Association. He indicated that after the Second Meet (29.01.2017), few more initiatives have been taken by the USAA on the basis of the suggestions that came from the members as well as the initiatives of the Executive Committee. These are;
 - a. A good number of seminars and workshops were organised in the Department with the help of Alumni members that will provide good exposure to the students of the Department.
 - b. To promote and popularise the subject "Statistics" in the State, USAA in collaboration with the P G Department of Statistics has launched Statistics Olympiad in our State during 2017 named "Statistics Olympiad 2017" for + 2 students. As a beginning this Olympiad was conducted in a limited scale at three Centres (i) PG Department of Statistics, Utkal University, (ii) Govt Autonomous College, Rourkella and (iii) Kendrapada Autonomous College, Kendrapada on 10.12.2017 (Sunday). We received good response and we will take up this programme in a bigger scale in the next year. The rank holders will be given their prize today.
 - c. With a view to improving vocabulary among students of Statistics, USAA in collaboration with the PG Department of Statistics, Utkal University organised a Debate Competition on 19.01.2018. The rank holders will be awarded their prize today.
 - d. Stating that USAA has many more agenda to go ahead, the President expressed his heartfelt thanks to the Alumni Members and the PG Department of Statistics for their contribution in achieving many of the agenda items during the last year and he solicited cooperation of all concerned in carrying the objectives of USAA further more in future.

- e. The USAA had made an endeavour to bring out a souvenir called souvenir "USAA" (ଭଷା: 2018) the second in its series. On the request of the President, the souvenir (ଭଷା: 2018) was released by Sri Dhirendra Kumar Patnaik, IAS, Hon'ble DPI (HE, Odisha) and circulated among the members.
- (ii) Hon'ble Guest of Honour, Dr Brahmananda Satapathy, Chairman PG Council, Utkal University in addressing the Meet expressed that USAA has created an opportunity for the Department to work in a strategic manner for all-round growth and prospect of the subject and guide the pass outs in a better way to build up their career in their subject.
- (iii) Hon'ble Guest of Honour, Dr Soumendra Mohan Patnaik, Vice-Chancellor, Utkal University in his address expressed that the subject matter "Statistics" has wide range of application in different fields. He personally felt that not only that the subject should open in under-graduate levels, there is also need for imparting training on applied branches of Statistics to the students so that students will opt for the subject keeping in view their future career prospect.
- (iv) On the request of the President, Sri Banshidhar Mahapatra, General Secretary, USSA read out the Annual Report of the Association for the year ending 2016-17 for information of esteemed members of USAA and all concerned. He gave a detailed account of various activities done by the USAA during last year, the present position and the steps to be taken ahead which was reflected in the Annual Report 2016-17 that had been circulated in the meeting. In giving the receipt and expenditure position of USAA during the year 2016-17, he stated that the opening balance at the beginning of the year was Rs.2327.95 (cash in hand "nil" and cash in Bank Rs.2327.95). The total receipt during the year was of the order of Rs.2,08,615.07 that included registration fee of Rs.20,000.00, contribution by Members of Rs.163,300.00, donation of Rs.25,000.00 and Bank interest of Rs.315.07. As against this, payments was of the order of Rs.181,400.00 that included Rs.750.00 towards printing and stationery, Rs.5,000.00 towards website, Rs.65,300.00 towards the Third Alumni Meet, Rs.2,000.00 towards Audit Fees, Rs.7,805.00 towards repayment of loan, Rs.100,000.00 towards fixed deposit (corpus fund) and the rest of Rs.545.00 towards miscellaneous expenses. The closing balance at the end of the year was of the order of Rs.29,543.02 (cash in hand Rs.300.00 and cash in Bank Rs.29,243.02). The account for the year 2016-17 has since been audited and the Audit Report is available in office. He also stated that for effective discharge of the functions of USAA, the Executive Committee is meeting at regular intervals. However, he solicited the cooperation of all the members in strengthening USAA and making it vibrant. He also requested all the Alumni Members to please give their considered opinion and valued suggestions for better functioning of USAA.
- (v) Hon'ble Chief Guest Sri Dhirendra Kumar Patnaik, IAS, DPI (Higher Education) in his inaugural address, expressed his satisfaction on the systematic and effective functioning of USAA and the tangible progress made during a short span of three years. He appreciated the concern of the USAA and the PG Department of Statistics that the subject "Statistics" is passing through a critical situation. He realised that in view of multidimensional application of the subject in different fields and the scope of good employment avenues for the students, there is need for opening the subject in under-graduate levels and filling of teaching posts in colleges. He expressed that as DPI, he will support the cause of the subjects as and when problems are brought to his knowledge. He advised USAA and the Department to focus on quality of teaching and work for its expansion and popularisation in the State.

- (vi) On the occasion of this Alumni Meet, Dr Jitendriya Sarangi, President, USAA felicitated Sri Dhirendra Kumar Patnaik, IAS, DPI (Higher Education, Odisha) and Dr Soumendra Mohan Patnaik, Vice-Chancellor, Utkal University on behalf of USAA.
- (vii) At the end, Dr Jitendriya Sarangi, President USAA requested the Chief Guest to please distribute cash prize and certificates to the rank holders in (a) MA / MSc examination in Statistics (2017),
 (b) Statistics Olympiad 2017 and (c) Debate Competition conducted by USAA. Accordingly, prizes and certificates were given to the rank holders on the occasion as under.
